INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA

Goppion Caffè SpA, with registered office in Preganziol (TV) Italy, via Terraglio n. 48, tel. +39 0422 490921, fax +39 0422 490905 and e-mail info@goppioncaffe.it, in its capacity as data controller of your personal data (hereinafter referred to as "Data Controller"), issues this information notice to the Data Subject in compliance with European and Italian regulations on the protection of personal data.

Purpose and lawful basis for processing

The Data Controller processes the data in order to take specific pre-contractual steps requested by the Data Subject, such as, for example, sending information on products or services (including sending the brochure, catalogue and/or other company information material) or a quotation, as well as to fulfil contractual and regulatory obligations connected with the business relationship and to pursue the legitimate interest to correctly manage the relationship, verify the Data Subject's solvency and manage any litigation.

The lawful basis for the processing is necessary for the above-mentioned purposes.

Data retention period

If the Data Subject does not become a Customer of the Data Controller after receiving the requested information, their personal data shall be processed for 12 months following the response, without prejudice to further storage for the time necessary to settle (however reached) any disputes that may arise.

Should the Data Subject become a Customer of the Data Controller, the data shall be processed for the entire duration of the business relationship and, subsequently, for the fulfilment of any obligations connected with or arising from the establishment of said relationship, for the period provided for by law and pursuant to the limitation period of the rights arising from the business relationship, without prejudice to further storage for the time necessary to settle any disputes (however reached) that may arise.

Nature of the data provision and consequences in case of refusal

Data provision is necessary, therefore any refusal to provide them in whole or in part may make it impossible for the Data Controller to pursue the above-mentioned purposes.

Categories of personal data recipients

The Data Controller will not disseminate the data but intends to communicate them to internal parties authorised to process them by virtue of their respective duties, as well as to sales agents, credit institutions, credit insurance companies, debt collection agencies, business information companies, factoring companies, consultants, business associations and/or organisations, professionals or service companies and public and private bodies, also further to inspections and audits.

Should these recipients process data on behalf of the Data Controller, they will be appointed as data controllers by means of a contract or other legal deed.

Transfer of data to a third country and/or international organisation

Personal data shall not be transferred either to non-European third countries or to international organisations.

Rights of the Data subjects

The Data Subject has the right to request the Data Controller to access their personal data and to rectify them if they are inaccurate, to erase them or restrict their processing if the conditions are met, to object to their processing for legitimate interests pursued by the Data Owner, as well as to obtain the portability of the data personally provided only if they are subject to automated processing based on consent or contract.
