INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA

Dear Supplier,

Goppion Caffè SpA, with registered office in Preganziol (TV) Italy, via Terraglio n. 48, tel. +39 0422 490921, fax +39 0422 490905 and e-mail info@goppioncaffe.it, in its capacity as data controller of your personal data (hereinafter referred to as "Data Controller"), issues this information notice to the Data Subject in compliance with European and Italian regulations on the protection of personal data.

Purpose and lawful basis for processing

The Data Controller processes the Supplier's personal data in order to pursue the lawful interest of carrying out qualification and/or monitoring processes with regard to the Supplier, to take pre-contractual measures, to fulfil contractual and regulatory obligations related to the business relationship, as well as to manage any litigation. The lawful basis for the processing is necessary for the above-mentioned purposes.

Data retention period

The Data Controller shall process the data for the entire duration of the business relationship and, subsequently, for the fulfilment of any obligations connected with or arising from the establishment of said relationship, for the period provided for by law and pursuant to the limitation period of the rights arising from the business relationship, without prejudice to further storage for the time necessary to settle any disputes (however reached) that may arise.

Nature of the data provision and consequences in case of refusal

Data provision is necessary, therefore any refusal to provide them in whole or in part may make it impossible for the Data Controller to pursue the above-mentioned purposes.

The categories of recipients of personal data

The Data Controller will not disseminate the data but intends to communicate them to internal parties authorised to process them by virtue of their respective duties, as well as to credit institutions, business associations and/or organisations, professionals or service companies and public and private bodies, also further to inspections and audits.

Should these recipients process data on behalf of the Data Controller, they will be appointed as data controllers by means of a contract or other legal deed.

<u>Transfer of data to a third country and/or international organisation</u>

Personal data shall not be transferred either to non-European third countries or to international organisations.

Rights of the Data subjects

The Data Subject has the right to request the Data Controller to access their personal data and to rectify them if they are inaccurate, to erase them or restrict their processing if the conditions are met, to object to their processing for legitimate interests pursued by the Data Owner, as well as to obtain the portability of the data personally provided only if they are subject to automated processing based on consent or contract.

The data subject shall also be entitled to withdraw consent for the processing purposes which require it, without prejudice to the lawfulness of the processing carried out until the time of withdrawal.
